## **Introduction**

This Annual Report of the Washington Conservation Guild (WCG) summarizes the activities and finances of the WCG for the fiscal year beginning on July 1, 2010 and ending on June 30, 2011. The purpose of this annual report is to communicate to our membership the activities that the WCG has undertaken during the fiscal year; it is made available on the Washington Conservation Guild website. Highlights from the membership year are presented at the May business meeting. Annual reports since 2003/2004 are available on the website, where members and other interested people may access them to learn about the Guild's activities.

## **Message from the President**

This past membership year has been a busy and productive one for the Guild. We had the usual schedule of monthly meetings, Angels Day, Booth events throughout the metropolitan area and intern gatherings.

Our full list of the year's meeting topics and venues is available later in the report but two highlights include venues that the Guild has not visited in some time. We had our February meeting at the Society for the Cincinnati and a wonderful turnout to hear Lois Olcott Price and Jesse Johnson speak on conservation training in Erbil, Iraq. After many years of having our Annual Business Meeting at Hillwood the Guild tried a new venue. We have had a monthly meeting at the International Brotherhood of Electrical Workers before but having the May Business Meeting at the IBEW allowed us to take advantage of their rooftop deck with gorgeous views of the city.

In addition to changed venues, this year marked another big change for the Guild. For the first time since 2003 Ernie Robertson did not host the refreshments at the Holiday Party. His spirit, holiday cheer and Santa suit always set the tone for the reception as he was the first thing you saw when you got to the second floor of the National Trust building. Thank you, Ernie for all your generosity and support of the Guild and feel free to drop by a reception any time, we miss you!

Angels Day at the National Park Seminary in Silver Spring, MD (November 2011) was another success for the Guild, providing expert re-housing for the NPS archive and a

fun day in a historic building for all of the Guild volunteers. Angels Day is one of the Guild's most significant outreach programs in that it improves collections care at an institution that cannot provide it themselves, provides a positive learning experience for the site staff, and a fun day for WCG volunteers. The Guild has been very fortunate to receive FAIC support every time we apply for a grant to support Angels Day activities.

This year marked the last year that the Guild sold our publication, Conservation Resources for Art and Antiques (2<sup>nd</sup> edition) at full price. Sales of the CRfAA2 have slowed to a mere trickle and in order to unload the many, many copies we still have in storage we have decided to give the CRfAA2 away as a premium with a \$5 donation. The costs for the second edition were paid for by the advertisements in the book there are no concerns regarding profit. Nancy Purinton as the final CRfAA2 chair has re-keyed the text of the collections care portion of the directory and once we are able to get it into pdf. format we will start selling it from the Guild website as a downloadable pdf. We have not set a price at this time, but it will probably be a modest cost.

Financially, WCG is in good shape. We used some of our assets to co-sponsor a symposium with Association of Preservation Technology (APTDC) "Climate Management in Historic Buildings: the Old, the Cold and the Mold" held March 24<sup>th</sup> and 25<sup>th</sup> at the Women in Military Service Memorial. The meeting was well attended and the presentations were recorded so APTDC is hoping to build a web-delivery interface for paid access to the recorded sessions, this would make up for the fact that there were no post prints and potentially realize additional funds from the Symposium.

## Highlights of the Year

The main achievements of the last year include:

- Held meetings at two venues we had not visited in many years: Society for the Cincinnati, Anderson House and the International Brotherhood of Electrical Workers
- Awarded 5 complimentary WCG memberships to interns/fellows, sponsored by the Sidney Williston Fund
- Held a September welcome reception for WCG intern/student/fellow members

- Held a successful Angels Day at Save our Seminary <http://www.saveourseminary.org/> in Silver Spring (November 2011)
- Displayed the WCG Outreach Booth at several outreach events including the ever-popular Festival of the Building Arts at the National Building Museum plus two new venues, Pioneers of Flight Family Day at the National Air & Space Museum (November 2010) and at our joint symposium with the Association for Preservation Technologies- DC Chapter, held at the Women in Military Service Memorial (March 2011).
- Completed re-keying of electronic version of chapters 1-18 of *Conservation Resources for Art and Antiques* in preparation for selling those chapters from the Guild website.

## Historical Background

The Washington Conservation Guild is a local non-profit organization, founded in 1967 and dedicated to the conservation of cultural property in our area. The goal of the WCG is to provide for the exchange of information among our members who are conservators, curators, collectors, framers, architects, students and others interested in the conservation, restoration, preservation and protection of objects of historical importance. We organize and hold monthly meetings that include social activities and talks on a variety of conservation-related topics. In addition, we sponsor specialized seminars and workshops for our members and the community. As part of our public education programs we participate in local art and antiques fairs and cultural events. We provide conservation information to the public through our website, a quarterly newsletter and our publication *Conservation Resources for Art and Antiques*. WCG membership is open to everyone and is a great local resource for learning about preserving your own artifacts, discovering what is happening behind the scenes at local museums, and providing a valuable network for conservation professionals.

## 2010/2011 WCG Board

The WCG board is a combination of elected and appointed members; details of positions and terms are in the WCG Bylaws. The WCG board usually meets from 4 p.m. to 5 p.m. on the day of our monthly meetings; for a full day in the summer; and at other times as deemed necessary.

## Membership Summary

The total number of WCG members during the 2010/2011 year was 215. Of these, 47 were student/interns, 4 were honorary members, and 16 memberships were complimentary, mostly to other conservation organizations. We had 44 new members this year. WCG's members are mostly in DC, MD, and VA, but we also have individual members in Arizona, Connecticut, Maine, Germany and the United Kingdom.

The total revenue from memberships was \$6,855.

Dues are \$30 for regular members, \$20 for students and interns, \$35 for international members. The Membership Secretary compiles an annual membership directory which is delivered electronically and supplies an addendum when necessary.

## Meeting Venues and Speakers

WCG membership meetings are usually held on the first Thursday of the month from October through May. Each meeting begins with a reception featuring light refreshments, followed by a lecture on a conservation-related topic. Seven regular meetings and a student/intern reception were held during the 2010/2011 membership year. Vice President **Hugh Shockey** secured the venues and made all general arrangements. Each meeting had two assigned Directors who were responsible for all

other details of the meeting. Most venues graciously host us at no cost, but we do sometimes have costs for guards, audiovisual, or other needs. WCG does not offer an honorarium for speakers, but we offer a Starbucks card as a token of our appreciation. When a speaker travels from out of the Washington, DC area, we will cover their travel costs. This year, speaker costs totaled \$208.10, which was \$191.90 under budget. Our refreshments costs were \$2,592.20 which was \$192.20 over budget. We allot \$250 per meeting for refreshments which is not a great deal of money so if the costs go over budget in the next year, the board may consider raising this budget figure. Refreshment contributions from the donation jar at our reception totaled \$428.20 this year.

### Public Outreach

#### Angels Project

**Lisa Young** coordinated a wonderful Angels Day with the group Save Our Seminary <http://www.saveourseminary.org/> which is the umbrella organization dedicated to the preservation of the National Park Seminary in Silver Spring, MD. The site is the home of a former school for girls which was later annexed to Walter Reed during World War II. The National Park Seminary is home to several unique historic buildings which are on the National Register of Historic Places but have also been incorporated into a

modern living community with new apartments and homes. The SOS has an archive, mostly dating from the girls school which was the focus of the Angels Day project.

Lisa worked with the site coordinator Chris Maines to organize supplies and logistics and on Saturday November 6, 2011 nineteen WCG volunteers spread out into the various balconies in the Seminary's gorgeous ballroom to sort, clean and re-house over twenty cabinets worth of archival material.

### Refreshments Chair

## Special Funds

### Sidney Williston Fund

This fund was started in honor of Sidney Williston, a private conservator in Washington, DC, for over forty years. His studio, Mario's Conservation Services, provided training for dozens of conservators, many of whom head their own labs today around the country. Sidney was a Fellow in the AIC and was an honorary member of the Washington Conservation Guild. The Williston Fund was created after his passing in 2000 to recognize his contributions to the Washington area conservation community and to the Guild in particular. This year, WCG awarded five memberships to the following fellows and interns in honor of Sidney Williston:

## Kendra Lovette Fund

This fund was started in December 2003 to honor Kendra Lovette, a long-time Washington area conservator. In 1977, she began working at the Library of Congress where she was the conservator in charge of treatment for the architectural drawings for the U.S. Capitol. Later she worked as a paper conservator at the Baltimore Museum of Art, and then was in private practice until the mid-1990s when ill health forced her into early retirement. Kendra died March 6, 2003, after a prolonged struggle with multiple sclerosis. Donations will be used to sponsor continuing education activities in her honor. The fund currently contains \$350.00
