### From the Desk of the President

WCG is starting off the 2008–2009 season with a bang. We had a productive summer board meeting at which we made several plans, and we already have three big outreach activities (this equals volunteer opportunities!), two meetings, and a symposium all lined up for September and October. I think it is easy to think of summer as a quiet time for WCG because there are no monthly membership meetings, but in fact, the board is hard at work behind the scenes making plans and transitioning duties to new board members.

I hope you will consider volunteering for the WCG outreach events, the first of which is taking place even before our first membership meeting: The Big Flea. This is the DC Big Flea Market, September 20–21, where we will display the WCG outreach booth and answer questions from the public about caring for their antiques and collectibles. We will also sell our publication Conservation Resources for Art and Antiques. This is a great opportunity for WCG to reach a wide audience and talk to people about conservation and preservation. Also, every sale of WCG's publication not only gets conservation information out to more people, but also supports WCG activities with the income it brings in.

The next outreach activity will be at the National Building Museum's Festival of the Building Arts on October 11. Our booth will be there and we will be giving hands-on demonstrations of ceramic repair and providing materials for kids to try it for themselves. This is a hugely popular event that WCG has participated in before, and it is a lot of fun. WCG's Outreach Booth Coordinator Nancy Pollak is the contact person for both of these events; see her call for volunteers in the pages ahead.

Finally, WCG's annual Angels Day will take place two weeks later on October 25 at the DC Historical Society, where the Angels will help to rehouse a collection of textiles. See Angels Coordinator Joanna Dunn's call for volunteers in this newsletter.

Also coming up on the WCG calendar: In September we will announce the winners of the Sidney Williston Fund awards at an intern reception at the Lunder Conservation Center organized by Intern Coordinator Kristin De-Ghetaldi. Thank you to the supervisors who submitted applications on behalf of their interns and fellows. The Williston Fund provides free WCG membership to five interns, and gets them involved in planning the monthly meetings. The Williston Fund accepts donations on an ongoing basis, so if you would like to support WCG's intern members, please consider donating to this fund, either by mail or online.

In October, WCG will co-sponsor with the National Association of Corrosion Engineers (NACE) and the Smithsonian Museum Conservation Institute (MCI) the Third Symposium on Conservation and Preservation of Historic Artifacts.

# Highlights of the Summer Meeting

Below are just some of the topics discussed and decisions made at the July 19 meeting of the 2008–2009 WCG board. Members are invited to contact the board for any comments and suggestions about these topics, or to get involved in any activities being planned.

In the morning, after general introductions and some administrative discussions, committee chairs reported on their activities and plans. After a delicious lunch break and the group photo, the meeting continued with officer reports and discussion of director duties, meeting venues, speaker ideas, and new business.

**Outreach Booth Coordinator (Nancy Pollak)** We still own the old outreach booth structure and would like to find a way to either sell or donate it to another organization that can use it.

We plan to participate in the DC Big Flea Market in Chantilly, VA, September 20–21. This is a large fair with 1000 vendors selling antiques and collectibles. Although there is a registration fee of \$180, we feel it is a good venue for getting visibility and for selling Conservation Resources for Art and Antiques (CRfAA). Other antiques fairs have much higher registration fees, so are prohibitive for WCG. We are compiling a list of other local fairs to investigate.

We have been invited to participate in the National Building Museum's Festival of the Building Arts on October 11, with a hands-on activity. We will bring an activity for kids involving reconstructing ceramic shards (broken flower pots). We did a similar activity about three years ago at this festival, it was a big hit.

### Main decisions:

- The board will propose a Bylaws change to make the WCG fiscal year run from July I to June 30. The present fiscal year is May I to April 30. The membership vote will be held at one of this year's meetings, to be announced.
- May 2009 will be the final monthly meeting announcement to be sent by postal mail; after that, all announcements will be sent by email.
- A WCG workshop on CAP Survey training is being organized for 2009.

Nancy would like to put together a "tool kit" of handouts and activities for the booth, in the same way that we have a selection of photos to choose from, to tailor the booth for different types of events.

**Intern Coordinator (Kristin deGhetaldi)** Williston Fund winners will be announced at a September reception, venue to be determined. [Update: Intern reception and tour to be held at the Lunder Conservation Center.] The board discussed the possibility of awarding more than five Williston awards per year if funds allow. Kristin will organize various lab tours and social events for interns and fellows throughout the 2008–2009 year.

**Newsletter Editor (Jayne Girod Holt)** Jayne would like to get more people as regular contributors to the newsletter, to help cover different events and features. Also, after the success of the themed newsletters of WCG's 40th anniversary, she would like to devote at least one issue a year to a particular theme.

**Angels (Joanna Dunn)** The 2008 Angels project will involve rehousing a collection of textiles at the DC Historical Society. Joanna will make a site visit, recruit textile conservators to help lead the project, set a date for the project, and apply for funding. [Update: Angels Day is October 25.]

**Website Guru (Erin Blake)** Erin reported on the visitation statistics of the newly designed website, showing graphs of site traffic. A spike in June was due to publication of the newsletter. There have been more than 1010 unique visitors (computers) to the website since May I, when the new site was launched. Key searches leading people to the site were "What is conservation" and "Washington Conservation Guild." Most activity is from the Washington DC area and the U.S., though visitors have come from 62 different countries.

Erin also gave an overview of WCG's Paypal account, which we set up when the website was updated. Visitors can now join or renew, make donations, and buy CRfAA online through Paypal. Although there is a small fee for each transaction, we hope that the ease of use will encourage more members to renew on time, and more people to donate to WCG or purchase CRfAA, thereby saving/earning money for WCG.

**CRfAA Fulfillment Chair (Michele Pagan)** Michele will continue to look for shops and other venues at which to sell CRfAA. It is already sold at some local historical sites and at outreach events. Book stores are more difficult as they require more of the profit or only stock it on consignment rather than buying it outright. Other ideas are to market it to local educators and conservation clinics. The book is an important source of income for WCG.

**Nominating Chair (Lisa Young)** Several positions will be open for the May 2009 elections: President, Vice President, Treasurer, Recording Secretary, and three Directors.

Public Lecture Coordinator This position is still open.

**Membership Secretary (Joanne Klaar Walker)** Joanne will experiment with different ways to make the Membership Directory less expensive to publish; it will be published in October, after announcing a last chance to join or renew at the October 2 membership meeting. The board decided to phase out the use of postal mail for sending monthly meeting announcements, to save money and be more environmentally friendly. May 2009 will be the final meeting announcement sent by postal mail.

**New Business:** Organization of a Workshop for 2009. Several workshop topics were suggested and discussed. It was decided to hold a workshop on Conservation Assessment Program (CAP) Survey training, which will be particularly beneficial for private conservators and museum conservators. Susan Peckham and Lisa Young will take the lead on organizing this. We will seek outside funding and also use WCG's Kendra Lovette Fund, which is for continuing education. The topic of digital photography was also considered an important one that would appeal to many WCG members, and may be considered for a future workshop.

**New Business:** Special Events for WCG Members. We discussed ideas for holding additional special events for WCG members. One event already planned for October is the Third Symposium on Conservation and Preservation of Historic Artifacts to be again co-sponsored with NACE and the Smithsonian's MCI. Other ideas to investigate: a tour of Lincoln's Summer Home, the Star-Spangled Banner, or the Treasury building. [Update: another suggestion is a tour and presentation about the conservation and restoration of the stained glass windows in a local church.]

**New Business:** Changing the WCG Operating Year. The board discussed and then voted to change the WCG fiscal year to July I to June 30. The current fiscal year runs from May I to April 30. This change was proposed because it better reflects the way WCG operates: the membership meetings take place from October through May, and the June newsletter is thematically related to this period, and so more logically belongs in the same fi-

nancial and membership year. This change will require a vote by the membership. The proposal will be presented to the membership in writing, comment will be invited, and a vote will be scheduled for one of the regular membership meetings. The membership renewal date will change to July 1.

**New Business:** Sources of Income/Website Sponsors. To pay for the website update, and to bring in income for future programs, the board will approach sponsors for the website's Sponsors page.

# Website Update

WCG revealed a new website design at the May I business meeting, just over a decade since the original website's debut in late 1997. The original website, designed by Mark Knight, served us well for many years, but it was time to take advantage of new technologies to make the website even better. We wanted to incorporate drop-down menus for easy access, a photo gallery, and online membership renewals among other things, but all without making the site harder for an all-volunteer force to maintain.

The idea of a website redesign began in 2005, under Lisa Young's presidency, as "part two" of a process that would begin with the logo redesign. Settling on a new logo, letterhead, and business card first would give us a head-start on website design, since a color scheme and certain graphic design elements would already be in place. In 2007, with Claire Peachey now president, we were ready for part two: the website.

In November, the website redesign committee of Eliza Gilligan, Jane Norman, Claire Peachey, Lisa Young, and me, Erin Blake, met to consider three competitive proposals. We decided on Vico Rock Media, a local company that specializes in working with small businesses and non-profits. Things moved incredibly quickly after our initial meeting with Vico Rock's Jill Kianka in mid-December. Armed with a new site architecture drafted by Emily Jacobson in 2006, the committee spent the first few months of the new year revising content and finding images for Jill to use in her design, and Jill regularly sent back drafts for our evaluation.

Preparing for the new website prompted us to examine where our website traffic comes from. We had always assumed our audience was mostly local WCG members wanting to know when and where the next meeting would be. We started gathering anonymous statistics, and learned that while about 75% of our traffic comes from the US, mostly from the DC area, we actually had people reaching the site from over forty different countries. The list included China, India, Korea, Belize, Kuwait, and Ghana. Moreover, the number-one search engine phrase that brought people to the site wasn't anything to do with DC or the guild as such, but "What is conservation?" It turns out that a significant number of people go to our website specifically for that information, which is now found under "Outreach" (or by entering "What is conservation?" in a search engine, of course).

Finally, none of this could have been done without the help of Walter Henry, the mastermind behind Conservation OnLine (CoOL) at Stanford. CoOL generously hosts our website and others like it at no cost as a service to the profession. We are especially grateful that Walter was encouraging about using new website technology. We're proud of the redesigned website, and hope that you find it a useful way to keep up with the Guild and conservation-related activities in the DC area. The point of the website is to serve the membership, so please let us know what you think, and how we can make the website even better.

# Calling all Angels! 2008 Angels Project: DC Historical Society October 25, 2008

WCG is soliciting volunteer participants for our upcoming Angels project. The history of the Angels Project dates to the 1980s when WCG collaborated with AIC to incorporate Angels projects at historic sites near AIC annual meetings. WCG has continued the tradition locally. Projects are completed in one day and have included rehousing collections, backing paintings, rolling textiles, and preserving daguerreotypes.

Last year volunteers examined and rehoused over 30 objects of Washington, DC, memorabilia from the Peabody room at the Georgetown branch of the DC Public Library. As many members will remember, the library was heavily damaged in a fire in April 2007. The Angels project allowed the items to be safely stored until the Georgetown branch of the library reopens.

This year's Angels project will be held at the DC Historical Society on Saturday, October 25, 2008. Volunteers are needed to rehouse the library's textile collection, which contains many historic costumes. The collection is currently stored in a closet next to a wall with visible water damage. Most of the textiles are being stored on wire hangers without any support. The Angels will rehouse these items so that they can be stored and handled safely in the future. The project is expected to last most of the day and lunch will be provided.

WCG members and interns are needed to sign up immediately so that a firm list of participants can be included in the Angels grant application being submitted by the September 15th deadline to FAIC.

### Letter to the Editor

Hello,

I was on the first Conservation Angels project team in 1988 at the Cabildo in New Orleans and later at the VHS in Richmond. I'll never forget the energy of Lisa Mibach in particular. She was a great leader.

I saw the article in your recent newsletter by accident and wanted to let you know I have never forgotten the experience. My career path never took me to conservation school but I had a large amount of hands on training before and after my Angels experience. I have become a champion of conservation in my museum career and was partly responsible for moving a WWII German submarine in Chicago indoors and out of a harsh climate.

One important lesson I learned in my Angels experience is the sense of leadership, setting a good example, commitment and service to the communities we serve. Yes it is a job, but it is a passion, a sense of deep caring, a need to understand history, connections, and significance, and to share it with others maybe indirectly by extending the life of an artifact or directly by talking to our communities in lectures, media, or our neighbors. If we can infuse this passion into the work of others, make the administrators more aware and WANT to make positive change, then we are doing a good job.

I have been out of touch with the Angels projects and am glad to know they continue. I'll have to get to an AIC meeting soon and volunteer again. It's worth it!

# Smithsonian American Art Museum & National Portrait Gallery 8th and G Streets NW

Early Art Conservation at Harvard: Technical Research and the Care of Art Works at the Fogg Art Museum (ca. 1900--1950) Thursday, October 30, 6 p.m.

In 1928, the Fogg Museum of Art established the first research and conservation department for a U.S. museum. But even before that, the Fogg was pioneering modern U.S. conservation practices and integrating research into artists' techniques and materials, as well as advancing art preservation. In this talk, Francesca G. Bewer, research curator at the Straus Center for Conservation, Harvard Art Museum, will give a brief overview of how and why the museum promoted a more scientific approach to the restoration and preservation of works of art, and how this affected the education of museum professionals, restorers, and artists during the first half of the twentieth century.

The Basics of Image File Management

Image file management is an important aspect of digital photographic treatment documentation. There are many different software programs and workflows that can be adopted for the purpose of image file management. This presentation will outline some of the options outlined in The AIC Guide to Digital Documentation for Conservators for image management and archiving digital image files; providing practical suggestions for conservators without IT support in their studio or institution. Though this program is directed toward professional conservators, anyone curious about image file management is welcome.
